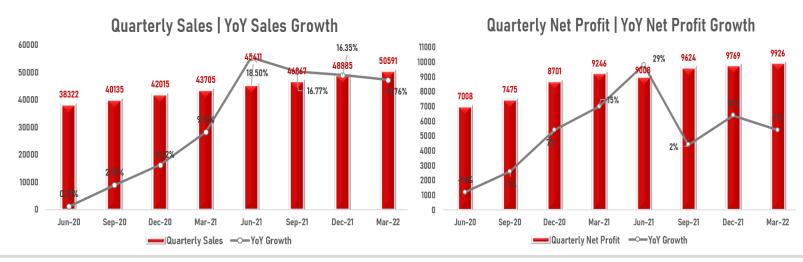

- IT stocks have been the worst performing sector so far in 2022, and March quarter results only extended the selling pressure.
- IT stocks have been under pressure largely on account of supply-side pressures, fall in demand amid macro headwinds, high attrition, steep valuations as well as selling by foreign institutional investors (FIIs).
- Even though TCS posted steady growth in Q4, its management predicts that margins will decline in the coming quarters.
- As per the leading global brokerage players, **peak revenue growth is behind and EBIT margins will be trending down from inflation coupled mean reversion in IT sector.**

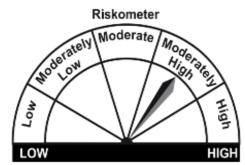
