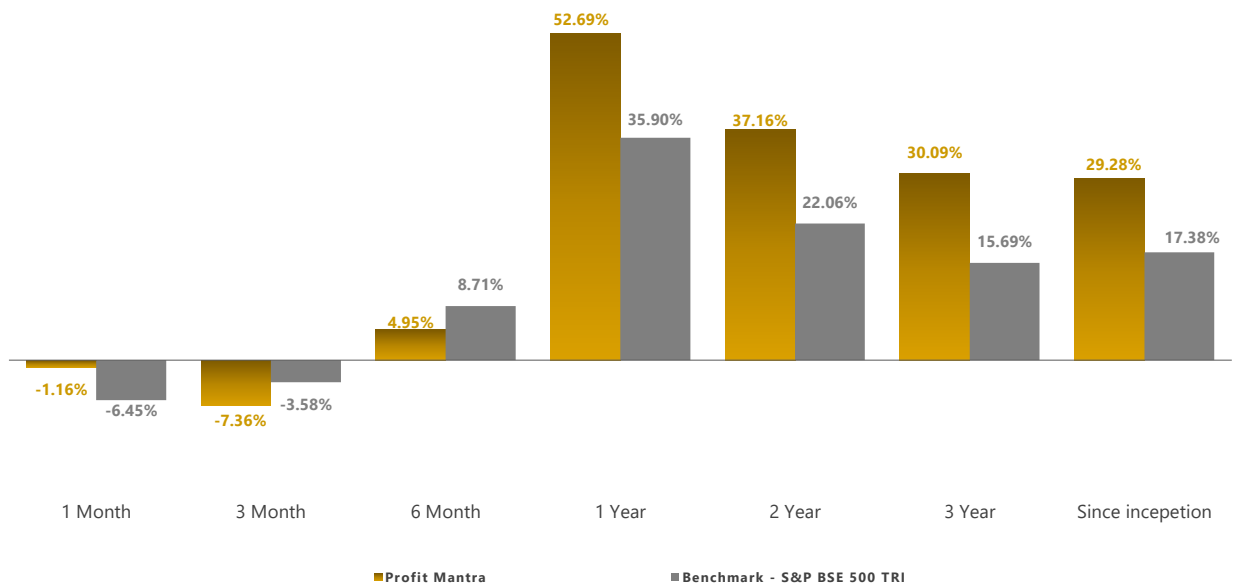

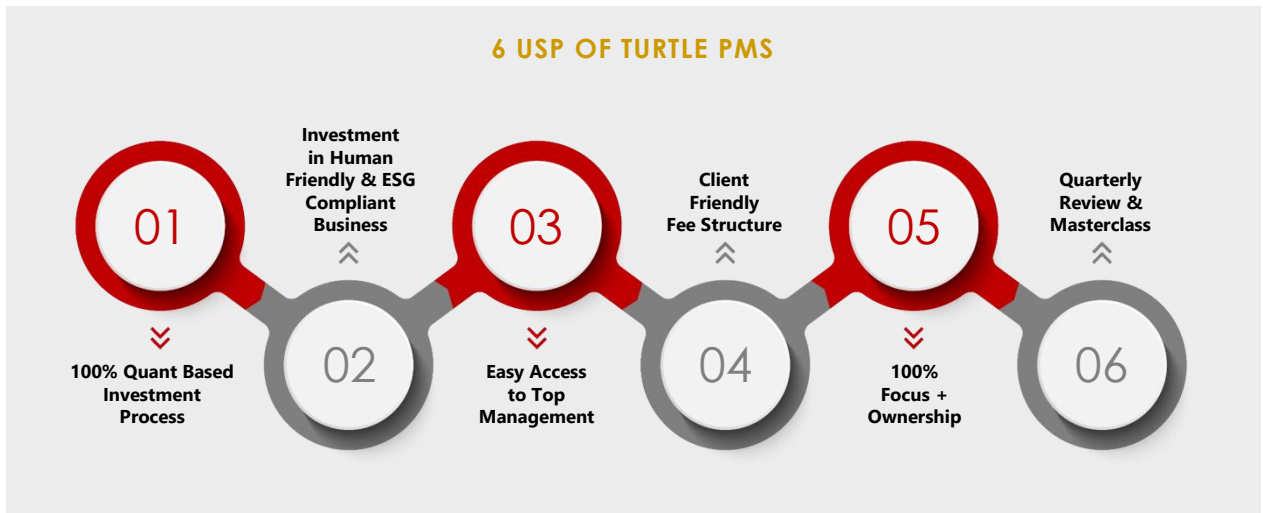
PERFORMANCE CHART

PROFIT MANTRA PMS Fund VS S&P BSE 500 TRI

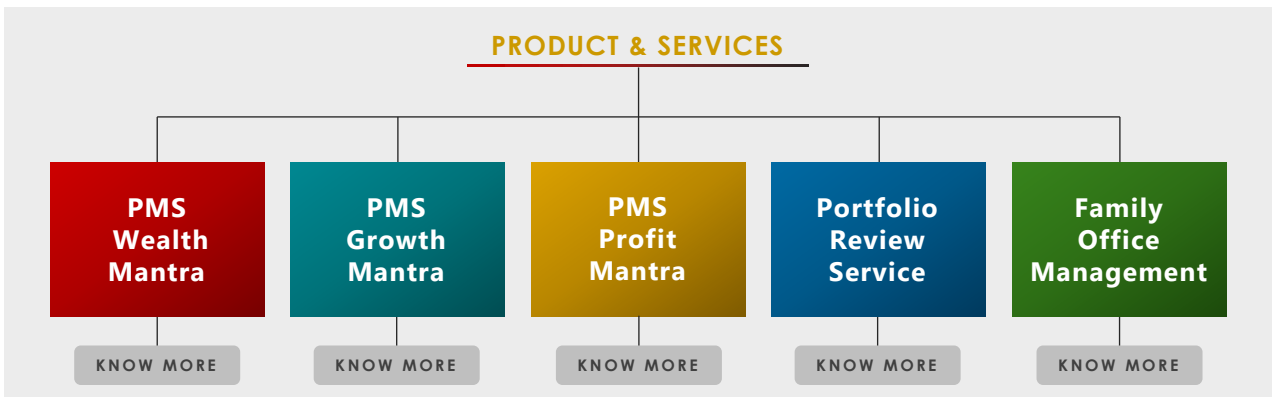
